



## Tree Fund Application

The Roeland Park Tree Fund is intended to supplement our partnership with Johnson County Contain the Rain by assisting homeowners with costs associated with maintaining and expanding the tree canopy within the City. These costs are limited to direct expenses for the purchase of approved new and/or replacement trees or for the trimming of Protected Trees on Covered Property as defined by Ordinance No. 1062, and outlined below. In 2025, the Tree Fund will provide up to \$25,000 for new trees and tree trimming, of which \$15,000 will be dedicated to those who meet stated income requirements, and \$10,000 will be provided for any Roeland Park homeowner. Below are the details regarding each category.

### **No Income Requirements:**

You must own a home in Roeland Park

### Tree Trimming:

- Approved applicants receive up to a 50% reimbursement capped at \$500 per calendar year to trim Protected Trees on Covered Property.

### New and Replacement Trees:

- Those wishing to purchase a new tree who do not meet income requirements will be referred to the Johnson County Contain the Rain program.

### **Income Eligible Requirements:**

You must be a **resident homeowner** (live in the home) in Roeland Park and meet the following income requirements to be considered for the income eligible benefits of the tree fund. Requirements are based on the Kansas City, Metro Area HUD Definition for Low Income (80% of median household income for the area).

Tree Trimming and Tree Purchases:

- Approved applicants receive up to \$1,500 per calendar year per property for tree trimming and/or tree replacement of Protected Trees on Covered Property or purchase of new Approved Trees.
- Applicants replacing or purchasing a new tree must select a qualifying native tree through Johnson County Contain the Rain program which will cover up to 50% of the cost of the replacement tree or new tree. The balance of the tree purchase and planting may be covered using allotted Tree Fund resources.
- The program is intended to be a reimbursement. On a case-by-case basis, the City may pay the contractor directly.
- Residents are required to provide at least two written quotes if the City is paying the contractor directly.

Staff will review all applications on a first-come-first serve basis. Applications will be accepted starting January 2, 2025, and will continue until funds are exhausted.

Application Instructions

To apply for the program, submit the following to Neighborhood Services in person, by mail, email, or fax:

- Completely fill out and sign the following application page.
- Those applying for income eligible projects, submit proof of the most recent annual income for all household members, such as a tax return and/or Social Security statement. See attachment for the types of income that must be reported.
